The Asia-Pacific region is the most underrepresented region at the International Criminal Court ("ICC" or "Court"), with only 34% of countries in the region being party to the Rome Statute. This event, organized jointly by the Court and The Hague Project Peace and Justice, seeks to explore the engagement of the region with the Rome Statute system and encourage students and young professionals from the region to consider a career in international criminal justice at the ICC. The Asia Pacific Forum started in 2018, aiming to facilitate an open dialogue about the Asia Pacific region's engagement with and contribution to international criminal justice. Following the second Forum in 2019 and third Forum in 2021, the ICC and the Hague Project Peace and Justice are delighted to host the fourth Asia Pacific Forum in a virtual format.

The event comprises two panel discussions, each followed by a Q&A session. In Session 1, an ICC judge from the Asia-Pacific region will give a lecture on "Recent Developments at the International Criminal Court". Session 2 will consist of ICC staff members from the Asia-Pacific region who will reflect on their experiences working in the international system and their motivation for working at the Court.
